

Wargalin Talo Bixin: Qorida Dwoooyinka Kontoroolan

Shuruudaha Dabagalka:

Sharciga Vermont (18 V.S.A. Firqada 84A) waxa uu dhigayaa in in ay samayso Waaxda Caafimaadka Vermont Nidaamka Dabagalka Dwoooyinka Laqoro ee Vermong (VPSM). VPSM waa kayd elektoroniga ah iyo nidaam warbixin oo lagu daba galo Booqashada II, III, iyo IV ee dwoooyinka kontoroolo. Dwoooyinka la kontarolaa waa dwoooyin abuuri kara mustaqbalka in si xun loo isticmaalo ama balwadba horseedi kara. Dwoooyinkan waxa lagu maamulaa Sharciga Dwoooyinka Lakontoroolo ee Federaalka ee (CSA)- sharcigani waxa uu dawlada Maraykanka ka caawiyaa inay la dagaalamaan isticmaalka khaldan ee dwoooyinkan. Dwoooyinka la kontoroolo waxaa kamid ah, oxycodone, methadone, hydrocodone, buprenorphine, clonazepam iyo diazepam.

VPMs waxay u adeegsanaan xarumaha caafimaadka iyo daryeelka caafimaad bixiyayaashu in dwoooyinka la kontoroolo loo adeegsado wixii loo qoray marka hore ee xaalada caafimaad ahay, inay ladagaalamaan adeegsashada xun, in lagu talaxtago, iyo in la badalo dwoooyinka la kontoroolo. Xogtani waxay gobolka ka caawisaa in dadaalka wax laga barto, daraasad lagu sameeyo, sharciga iyo isticmaalka khadlan in lagaga hortago.

Xogtani waa sir, marka laga reebo marka sharci loo bixinayo, oo ayna hoos iman sharciga kaydka dadwaynaha.

Advisory Notice: Prescriptions for Controlled Substances

Monitoring Requirements:

Vermont law (18 V.S.A. Chapter 84A) requires the Vermont Department of Health to establish the Vermont Prescription Monitoring System (VPMS). The VPMS is an electronic database and reporting system for monitoring Schedules II, III, and IV controlled substances. Controlled substances are drugs that have some potential for abuse or dependence. These drugs are regulated by the federal Controlled Substances Act (CSA) – this law helps the US Government fight against the abuse of these drugs. Examples of controlled substances include oxycodone, methadone, hydrocodone, buprenorphine, clonazepam and diazepam.

The VPMS serves as clinical tool for health care providers to promote the appropriate use of controlled substances for legitimate medical purposes, while deterring the misuse, abuse, and diversion of controlled substances. The data is used to support states' efforts in education, research, enforcement and abuse prevention

This data is confidential, except as provided in the law, and is not subject to the public records law.

Data Collected:

- Patient Name, Address, and Date of Birth
- Drug Dispensed, Date, Quantity and Dosage, Number of Days' Supply, Number of refills
- Patient's Health Care Provider
- Pharmacy Name (where prescription is filled)
