1. Call to Order; Call the Roll; Acknowledge Guests:

Saran McCLain, Chair, called the meeting to order at 12:03 p.m.

2. Approval of the Minutes of the April 6, 2022 Board Meetings:

Ms. Hunter moved to accept the minutes of the April 6, 2022 meeting. Dr. Tandoh seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

3. Board Issues (Dr. Bernstein):

Ms. McClain and Ms. Hunter participated remotely in ehe Federation of State Medical Boards annual meeting.

- Ms. McClain reported that Ms. Hunter attended the Federation of Physician Health Programs (FPHP) work session that focused on the emerging concerns about the trauma medical professionals have experienced during the pandemic. The FPHP is encouraging medical boards to prepare for potential cases related to mental health concerns and ask medical boards to be supportive rather than punitive.
- Ms. McClain will share highlights from House of Delegates meeting next month and will send an email with the full report for members to read.

4. Administrative Updates (Mr. Herlihy):

Mr. Herlihy provided a brief update about staffing: Caitlin Linton has joined the team as a temp to support the licensing work.

Mr. Herlihy let members know that he and Ms. LaFond are working on a spring email that they plan to send out this month to BMP licensees. Topics include:

- An advisory will be posted regarding advertising by CME providers that may suggest to some licensees that their specific courses are required for Vermont medical license renewal. Members were advised that if licensees inquire they should tell licensees that no particular CME course is mandatory. Mr. Herlihy has previously worked with the Attorney General's Office to respond to advertisements that were believed to be misleading and will follow up again with Consumer Protection Division.
- Another notice will be included regarding attempts to defraud licensees. The Board has previously sent notices about schemes to defraud physicians and other professionals by high pressure calls where criminals claim to be medical board representatives, DEA agents, or other authority figures and demand immediate payments or face suspension of licenses or DEA authorizations. The Board has received information that there has been another recent surge in this activity. Dr. Hildebrant shared that this has been happening in Rutland County with the callers claiming to be from the County Sheriff's Office and with the caller id showing that it is the Sheriff's Office calling.
- Notice will be put out about the updated Board Rules. The staff is still waiting to have an
 official effective date approved by the Agency of Human Services. This item will
 determine the timing of the email as licensees should be notified of the effective date of
 the changes.
- Members suggested that this would be a good opportunity to include messaging about the availability of assistance for licensees who are contending with mental health challenges, as noted during the discussion of the FPHP meeting. This topic will be included in the email.

Mr. Herlihy also mentioned that some of the actions taken by the Federation of State Medical Boards should prompt policy reviews by the Board. The Federation approved an update to the Model Policy on Telemedicine; the Board's Telemedicine Policy was modeled on the FSMB version and should be reviewed in light of this update. FSMB also issued a statement on misinformation and disinformation by physicians, which the Board may want to consider. Finally, FSMB updated guidance regarding emergency preparedness that should be reviewed.

5. Presentation of Applications:

Applications for physician, physician assistant and limited temporary physician licensure were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

Ms. McClain moved for the issuance of physician licenses and physician assistant licenses. (See Appendix A)

Dr. Hildebrant made a motion to accept all applicants for licensure as presented. Seconded by Dr. Tortolani. The motion passed; opposed: none; abstained: none; recused: none.

Ms. McClain moved for the issuance of limited temporary licenses to practice medicine. (See Appendix A)

Dr. Hildebrant made a motion to accept all applicants for licensure as presented. Seconded by Dr. Bernstein. The motion passed; opposed: none; abstained: none; recused: none.

6. Other Business:

Continued discussion of Board of Medical Practice Mission Statement.

Ms. McClain presented the revised mission statement for consideration: The Vermont Board of Medical Practice protects and promotes the health and safety of Vermonters by ensuring professional integrity through licensure of health care practitioners and investigation of complaints in a fair manner that is respectful to all parties.

Dr. Hildebrant made a motion to accept the mission statement as presented. Seconded by Mr. LeCours. The motion passed; opposed: none; abstained: none; recused: none.

- Legislative update an overview of actions taken on bills of interest to the Board.
 - H.655 provides two new telehealth options: a short-term telehealth registration that is very limited and a telehealth license that is limited to telehealth and only for a limited number of patients. The options will have lower application fees than the full licenses and a less demanding application process. The bill passed and is expected to become law. The Board will define the application processes in rules.
 - No action has been taken on the bills that would have changed the scopes of practice for optometrists and psychologists. Given that the session is anticipated to end very soon it appears that no action will be taken on those items this year.
