The collaborative approach to school nurse leadership will help the nurse:

- Function as a leader of school health services.
- Improve clinical nursing skills.
- Use the Vermont Standards of Practice: School Health Services Manual as a practice guide.
- Participate in and lead on student support teams and on supervisory/district wide (i.e. PBiS, MTSS, etc.) teams.
- Ensure continuity of school health services within the supervisory union/school districts, including policy, procedures, and documentation consistent with evidence-informed care and the role of the school nurse as defined by the SOP Manual and national specialty nurse practice competencies.
- Supervise those (LPNs, and RN's, UAPs) who are not licensed school nurses.
- Act as adviser/ resource to school administrators on school health within the frame work of Whole School, Whole Community, Whole Child, (CDC 2014); a blending of the former CSH and the Whole Child approaches.
- Recognize that each school nurse practice is unique, shaped not only by the expectations and resources of the local, state, and national stakeholders in school health, but also by the personal and professional qualities of the nurse.
- Engage as a mentor, adviser, teacher, resource, and promoter of professional practice and growth to a team of nurses.
