3. Approval of Minutes of the December 2 and December 16, 2015 Board Meetings:

5. Administrative Update (Mr. Herlihy):

Mr. Herlihy stated that there are two outreach events in coming weeks. First, on January 13 he will visit Southwestern Vermont Medical Center in Bennington to do a

presentation on prescribing and the new VDH rules on opioids and VPMS. He will be accompanied by Investigator Christiana Coyner. The presentation will cover some of the same ground as the Grand Rounds presentation done with VPMS and the Department of Public Safety, but the hospital requested training specific to the rules. On January 29, Mr. Herlihy and Investigator Nenninger will attend the annual meeting of the Physician Assistant Academy of Vermont to make a presentation. Board Chair Mr. Hoser will also be in attendance.

6. Presentation of Applications (12:30 p.m. – 12:45 p.m.):

Applications for physician and physician assistant licensure, and certifications of radiologist and anesthesiologist assistants were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

7. Board Selection of Physician Representative to the APRN Committee (12:45 p.m. – 1:00 p.m.)

Mr. Herlihy noted that Dr. Burgee had been nominated to replace Dr. Hayward as the physician representative to the APRN committee and that he had not received any other nominations.

8. Presentations to the Board (12:45 p.m. – 1:15 p.m.):

Ms. LaFond presented statistics regarding the readership of the newsletter that was disseminated to all licensees in October 2015. She noted that of the 4019 recipients, 1687 (or 42%) opened the email; 714 of the 1687 individuals clicked links to various articles; and 2220 (or 55.2%) did not open the email. There was discussion regarding the issues with the email messages from the Board going to spam mailboxes, issues with licensees who unsubscribe from the system and concerns about licensees not receiving Board communications due to invalid or duplicate email addresses. Ms. LaFond noted that with each renewal cycle there are emails that bounce back or are undeliverable, but with the efforts of Ms. Hayes and Ms. LaFond to communicate with hospital and licensing coordinators, the percentage of bounced/undeliverable emails continues to decrease.

13. Other Business:

Continuation of Discussion of VDH Policy Memo on Analysis of Opioid Prescribing Patterns

It was agreed that this item, which was continued from the December 2015 meeting, would be postponed to be taken up at the February 2016 meeting. Members indicated that they are still interested in hearing more about this subject from Dr. Chen or an appropriate representative from the Health Department.

Invitation to participate in FSMB meeting regarding anti-trust issues associated with the U.S. Supreme Court decision in North Carolina State Board of Dental Examiners v. Federal Trade Commission, No. 13-534, February 25, 2015.

Mr. Herlihy related the background about this case and its implications for Vermont. He noted that he has not considered it an urgent issue for the Vermont Board, but suggested that there needs to be careful consideration of the issue and that this meeting offers an opportunity to obtain expert advice from other states and FSMB. He noted that the next agenda item is an example of how the Board can be in a position of having to take action on matters that might prompt allegations of anti-competitive actions. Mr. Hoser agreed that it would be of benefit for Mr. Herlihy to attend the meeting so as to obtain a better understanding of the related issues.

Mr. LeCours made a motion to support Mr. Herlihy's participation at the FSMB meeting regarding anti-trust issues associated with the US Supreme Court decision, No. 13-534 to be held in Dallas, TX on February 25, 2016. Dr. Hayward seconded the motion. The motion passed; opposed: none; abstained: none; recused: none.

Board Statement on Use of Lasers.

Mr. Herlihy reviewed the background of the "Use of Lasers" issue that has come before the Board in 2008 and 2013. He noted that the Board issued a statement in September 2008 that established certain use of lasers and other modalities as

the practice of medicine, and in July of 2013, the Board passed a motion revising the language to comport with amendments to 26 V.S.A. § 1311 passed in 2011.

Mr. Herlihy informed members that the Administrative Rules of the Board of Barbers and Cosmetologists include language that might be interpreted by licensees of the Board of Medical Practice that it is acceptable to delegate certain tasks that constitute the practice of medicine to persons not licensed or certified to practice any health care profession. He asked members whether or not the Board should consider adding to its statement on this issue to include a position on the acceptability of such delegations. Several members offered comments regarding concerns about delegation of this medical task to individuals not licensed or certified in any relevant health care profession. It was noted that delegation would not be appropriate for all health care professions. The issue was continued to the February meeting and Mr. Herlihy was asked to propose specific language for an amended policy statement.

FSMB Invitation for Comment on Draft Report on Marijuana and Medical Regulation. Enclosure to Board packet

Mr. Herlihy noted that the FSMB draft report is largely directed at physicians who are involved in prescribing marijuana as a medical treatment or making a recommendation for use of marijuana. He explained that the Vermont program does not feature any prescribing or recommendations for marijuana by physicians. Instead, in Vermont, the physician's role is limited to providing information about how long an applicant has been a patient and about the patient's condition. In light of that, he suggested that the Vermont Board does not have a direct interest in this draft report and suggested the Board might decline to comment on the report for that reason. There was no further discussion of the report.

Legislative Updates

Mr. Herlihy briefly reviewed bills that have recently been introduced in the 2016 legislature: S201 and S243, which focus on opioid prescribing practices. He requested that members review the bills before the February meeting at which he will ask the Board to take a position regarding each proposal. He noted that the Board could support, oppose, or propose modifications to the bills. Members suggested that it would be helpful to have Dr. Chen or another representative of the Health Department provide the Department's view on the bills.


