- Commission terms We have received guidance from the Governor's office. The State
 positions that have been identified (Secretary, Commissioner, Director..) is an
 appointed position which do not have term expirations. The remainder of the
 commissioners have to be reappointed every three years. Terms begin and end every
 year on February 28 and a list of term end dates is being sent to the commissioners. for
 the first are now in place
- Beth Novotny spoke to the group about how to prepare for the legislative process. Her comments included the importance of identifying where there are areas of the State that do not have access to behavioral health programs in the legislative report. She stressed that when meeting with the legislature it is important to show a map of the State with all of the gaps. Beth recommends we don't pursue legislation immediately, however if there is money needed to move the Commission to the next phase, we should ask the legislature to help. She encouraged the group to take advantage of the COVID funds if possible. Beth offered to assist the Commission as needed.
- Following Beth Novotny's comments a list of items that needed to be answered for each
 discipline was distributed and working groups were assigned for Law enforcement, Fire,
 EMS, Dispatch, and Corrections. Each group was asked to meet separately and answer
 the following question by November 10:
 - Services that exist
 - Peer Support, Clinicians, EAP services, Education, Family Support, Suicide
 Prevention
 - Are services state-wide, regional, or organizational
 - What services exist to support families

- What trainings exist to support
 - Clinicians
 - Peer Support Team
 - Resilience, De-escalation Training
- Barriers that allow access to service
 - Qualified clinicians
 - Who exists?
 - How do we attract and retain?
- Legislation currently in place
- Are there impediments to reporting issues
