 - **Request for Rulemaking on IV Contrast Issue** – The Board received a request for rulemaking on the subject of allowing radiology technicians to administer IV Contrast while being supervised only by a remote physician using two-way audio-visual communication. The Vermont Department of Health acts as the agency for issuance of rules relating to the Board, but the Board is being asked to consider establishing a position on the issue. Relevant documents, including the request, a CMS proposed rule on the issue, a journal article on contrast side effects, and an Alabama decision on the issue, are attached.
 - **Discussion of Issuing Press Releases about Board Actions** – The Board currently posts Actions on the website, as required by Vermont law, but press releases are not issued. A question has come up in an investigative committee about the possibility of issuing a press release about an action. The Kansas Board of Healing Arts policy is attached as an example of an approach that allows for release in some instances.

- **IMLCC Data Report** – A recently released report from the IMLCC with data about the number of licenses issued by all participating boards is attached to the agenda. The data includes total physician licenses issued by each board, the number of physician licenses issued via the IMLCC, and the percentage of licenses issued via the IMLCC.
