• Approval of the Minutes of the February 5, 2025, Board Meeting:

D. Philibert moved to accept the minutes of the February 5, 2025, meeting. Dr. King seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

• Board Issues (Dr. Hildebrant):

Accessing HSIN – The Chair reminded members that they would need to obtain a
Login.gov account to be able to access the HSIN system after March 6, 2025, as
indicated in messaging from HSIN. Staff advised that they will monitor HSIN
access and send updates. Staff will assist any member who encounters difficulties
establishing a Login.gov account. Staff will also develop plans for temporary

alternative ways to share materials with those who are delayed in setting up an account.

- S.64 An act relating to amendments to the scope of practice for optometrists Dr. Hildebrant reported on his experience testifying on S.64, which is the latest in a series of bills introduced that would expand the scope of practice of optometrists to allow them to perform a list of specified procedures. The "advanced procedures," as referred to in the bill, are considered surgical interventions and are currently performed only by ophthalmologists. Dr. Hildebrant noted that the Senate Government Operations Committee (SGO) was unreceptive to concerns raised by witnesses testifying in opposition to the bill. D. Herlihy added that the Office of Professional Regulation had previously conducted a study on expanding the scope of optometrist practice as proposed in S.64. That study concluded that optometry scope of practice should not be expanded to include surgical procedures; the Committee sent a letter to the Office of Professional Regulation indicating that the SGO Committee had concluded optometry scope should be expanded. OPR conducted another study that determined optometry scope should be expanded. The bill was voted out of SGO and next will be taken up in the Senate Health and Welfare Committee.
- Administrative Updates (David Herlihy): D. Herlihy provided additional detail about the licensing data shared with members during the March meeting. When reviewing tables that report the number of licenses issued and renewed by year, PA renewal numbers can seem misleading. Because the PA renewal period begins in an odd year and ends in the following even year (November 1 to January 31) the odd year and even year numbers need to be combined to determine the number of PAs who renewed. R. Hunt advised that 1099 forms had been sent to members for their 2024 per diem payments. Members were asked to let staff know if they have not received a 1099.

Other Business:

- Legislative Update:
 - S.28 --An act relating to access to certain legally protected health care services D.Herlihy reported that he had testified in the Senate Health and Welfare Committee (SHW) on February 27th. Members were provided a summary of the version of the bill that was voted out of SHW on February 28th. The bill now includes a provision that allows the Board

> and OPR to withhold personal contact information of licensees from public disclosure. Only addresses and telephone numbers designated as public would be subject to public disclosure. The bill also revises sections of the Vermont Consumer Protection Act. The Act had been amended in 2023 to add provisions applying specifically to limited services pregnancy centers. Changes in the bill as approved by SHW would make the Act apply to all advertising of health care services. The new provisions target statements in advertising of health care services that that are untrue or clearly designed to mislead the public about the nature of the services provided. The bill also would make minor revisions to the wording of sections pertaining to licensees who allow their name or license to be used by entities offering medical services, and sections pertaining to delegation of medical tasks. D. Herlihy also reported that although he had presented the Board's position opposing the creation of an exception to allow prescribing medication to terminate an abortion based only on a questionnaire, SHW passed the bill with that exception intact. The bill will be taken up in other committees in the Senate and the House.
