• Administrative Updates (D. Herlihy):

- D. Herlihy acknowledged the progress on the SRPS project to replace CAVU. He thanked T. Hayes and all the staff for their contributions.
- R. Hunt reviewed the Summer 2025 Newsletter reporting statistics. 97% were successfully delivered and 66% of recipients opened the email, which are good rates for mass emails. Additional data was shared about the specific items.

D. Herlihy shared a report from the Interstate Medical Licensure Compact Commission about the number of licenses issued by each member state.

Request for Rulemaking on IV Contrast Issue

D. Herlihy summarized the request presented to the Board for rulemaking on the issue of supervision of radiologic technicians when administering IV contrast and noted each of the attachments provided to the Board in support of their consideration of the issue: the request, the CMS proposed rule, the ACR statement, the Alabama statement, and a journal article on radiographic contrast material. Members were reminded that the Board is not in the role of the rulemaking authority. Instead, the task is to provide input to the Department of Health (VDH), which will act on the request. Members were also informed that while the statute calls for the request to be denied or for rulemaking to commence within 30 days, the request was received shortly after the last meeting, so it is not possible here to meet that time limit. The requester was informed of that and responded that they are okay with the Board taking the time necessary to form a position on the issue.

After discussion, members elected to table the issue. They asked for additional information:

- has the Vermont Medical Society taken a position on this?
- is the requester working with potential clients in Vermont, or is this only preparatory?
- if they do have one or more clients, has a client requested official action on the issue?
- does the Office of Professional Regulation have a position from their prospective of regulating radiologic technicians?;
- is this a matter within the rulemaking authority of the Board or VDH?
