• Request for Rulemaking on Supervision of IV Contrast Administration (Continued)
The Board continued the discussion that began at the August meeting about
establishing a position as to whether the Department of Health should engage in
rulemaking as proposed in a request submitted to establish a rule allowing remote

supervision of radiologic technologists when administering IV contrast.

D. Philibert moved that the Board recommend that the Vermont Department of Health not engage in rulemaking as requested in the request submitted. The motion was seconded by Dr. Odigie. The motion passed unanimously, Opposed: none; Abstained: none; Recused: none.

#### Designation as a Wellbeing First Champion for 2025

D. Herlihy shared that the Board has again been designated as a Wellbeing First Champion. This is the third time that the Board has achieved the designation, which tells licensees and applicants that the Board's applications and practices comply with recognized best practices for supporting healthcare workers in being able to seek mental healthcare without fear of adversely affecting their license. Staff will work on plans to share news of the designation with licensees and applicants.
