• Approval of the Minutes of September 3, 2025, Board Meeting:

D. Philibert moved to accept the minutes of the September 3, 2025, meeting. R. Ciappenelli seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

- **Board Issues:** Dr. Hildebrant thanked the Board as he prepares to transition to his new role as Health Commissioner.
- Administrative Updates (D. Herlihy):
 - Members were updated on the progress of the SRPS IT project. BMP staff hosted
 Tyler partners on September 22 and 23 for two days of in-person testing and

collaboration. The project is on target to meet the planned date for "go live" in March 2026.

- Members were advised that a new policy has been announced for remote work.
 Vermont state employees will be required to work in the office three days per week beginning December 1. It was noted that there are challenges finding space for all VDH central office employees at the Waterbury complex. A concern for the Board is having private workspace for staff, which is necessary given the requirements to maintain confidentiality of HIPAA information and the Board's investigative cases.
- Members were remined that volunteers are needed for a hearing panel to hear the case of In re: Sarkaria. A minimum of three members will be needed, with at least one MD member and one public member; only members of the North and Central Investigative Committees are eligible to serve on this hearing panel. The hearing is scheduled to take place beginning on December 15 and estimated to last for three days.
- The VPHP Liaison meeting is scheduled for November 3, 2025 from 5:00-6:00pm.
- The FSMB has invited one Board member and one staff member to attend a training in Trauma Informed Regulation on Friday, February 27, 2026. More information to follow.
- D. Herlihy delivered remarks thanking Dr. Hildebrant for his time and service as Board Chair.

Other Business

 Board Officers: The appointment of the current Board Chair to be Commissioner of Health effective October 13 gives rise to a need for the Board to address Board Officer succession for the remainder of the calendar year.

D. Philibert made a motion to accept Dr. Greenberg as Acting Board Chair for the period, October 13 – December 31, and for Dr. Tortolani to be Acting Vice Chair. Dr. Tandoh seconded the motion. The motion passed unanimously. An election for officers to serve beginning in January 26 will be held at the December meeting. At the November meeting there will be a call for nominations and a request for members to serve on an ad hoc nominations committee.

• Report by Dr. Ireland on the APRN Subcommittee:

Dr. Ireland shared that he had attended a meeting of the APRN Subcommittee in his role as the BMP representative to that group. The APRN Subcommittee voted to recommend to the Board of Nursing that the Board of Nursing pursue an amendment to Vermont law to remove the requirement for new APRNs and APRNs who are changing their role and/or population focus to practice for a defined period subject to a requirement to have a collaborating provider. The Board of Nursing will consider the issue at their October or November meeting.

Dr. Ireland moved that the Board state opposition to the proposal approved by the APRN Subcommittee to sunset the transition to practice provisions of 26 V.S.A. § 1613 based on concerns for patient safety, a lack of support for inexperienced APRNs, and the costs associated with inexperienced providers issuing unnecessary orders for testing and consultation. Dr. Tortolani seconded the motion. The motion passed unanimously.

- DEA representatives have offered to provide an informational presentation at the November meeting. Members were asked to submit their questions and suggestions for the presentation.
