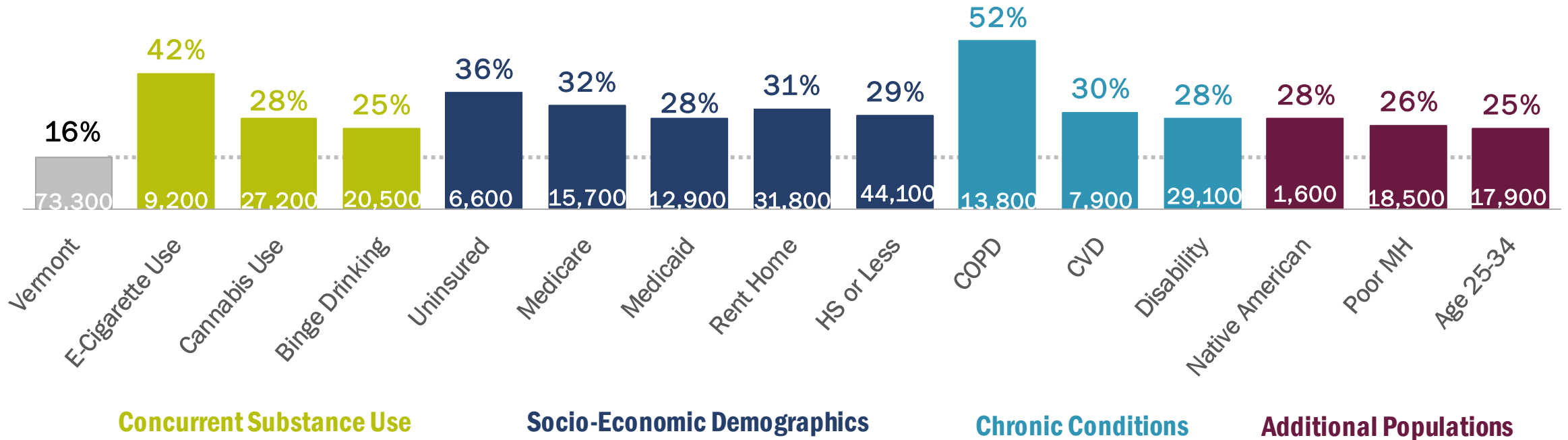




# Adult Populations Who Smoke Cigarettes at Higher Rates Than the Statewide Rate (2021 BRFSS)

Vermonters who use e-cigarettes, those with COPD, and uninsured adults smoke cigarettes at the highest rates.

## Current Smoking Prevalence (%) and Estimated Number of Vermonters



**Graph Interpretation:** Gray bar shows the VT estimate. Colored bars show smoking prevalence and white text provides the estimated number of Vermonters who smoke within each sub-population. *E.g.*, 28% of adults who currently use cannabis smoke cigarettes, about 27,200 Vermonters.

**Data Notes:** E-cigarettes refer to all nicotine-containing e-vapor products, including e-hookahs, vape pens and e-cigars, among others; Cannabis and E-Cigarette Use is in past 30 days; Binge Drinking=5 or more drinks on an occasion (men), 4 or more for women in past 30 days; Rent Home includes those with other accommodations; HS=High School; CVD=Cardiovascular Disease; Native American combines 2020 and 2021 data; Poor MH (Mental Health)=14+ days with poor mental health in past 30; **Data Source:** VT BRFSS 2021; Percentages are age-adjusted to U.S. 2000 population & estimated counts rounded to nearest hundred Vermonters (not age-adjusted).

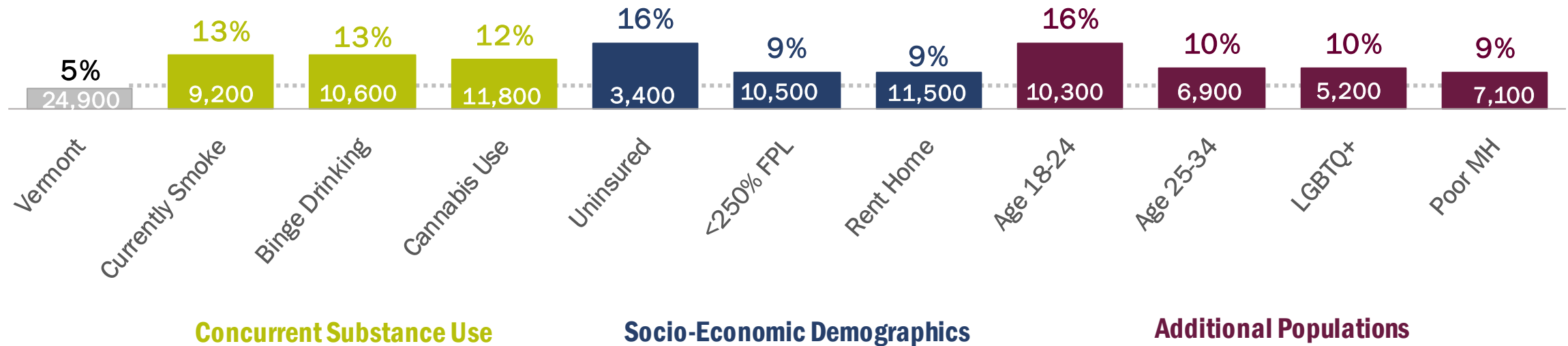

## Adult Populations Who Use E-Cigarettes at Higher Rates than the Statewide Rate (2021 BRFSS)

Young adults ages 18-24, those who currently smoke, binge drink, or use cannabis, and uninsured adults use e-cigarettes at the highest rates.

Current E-Cigarette Prevalence (%) and Estimated Number of Vermonters



**Graph Interpretation:** Gray bar shows the VT estimate. Colored bars show e-cigarette prevalence and white text provides the estimated number of Vermonters who use e-cigarettes within each sub-population. *E.g.*, 13% of adults who currently smoke use e-cigarettes, about 9,200 Vermonters.

**Data Notes:** E-cigarettes refer to all nicotine-containing e-vapor products, including e-hookahs, vape pens and e-cigars, among others; Currently Smoke and Cannabis Use are in past 30 days; Binge Drinking=5 or more drinks on an occasion (men), 4 or more for women in past 30 days; FPL=Federal Poverty Level; Rent Home includes those with other accommodations; LGBTQ+=Lesbian, Gay, Bisexual, Transgender and other sexual orientations; Poor MH (Mental Health)=14+ days with poor mental health in past 30. **Data Source:** VT BRFSS 2021; Estimated counts are rounded to the nearest hundred Vermonters and neither counts nor percentages are age-adjusted.
