- **Other Business:**
 - **Possible withdrawal of Michigan from the Interstate Medical Licensure Compact (IMLC).** The law enacted by Michigan in 2018 to join the IMLC contained a “sunset” provision that provided for the law to terminate absent action taken to extend it. Unless Michigan acts by March 28, 2026, Michigan will withdraw from the IMLC that day. Each chamber of the Michigan Legislature has passed a bill that would keep the state in the Compact, but it is unknown if either will become law in time. A number of physicians hold Vermont licenses obtained via the IMLC using Michigan as the “State of Principal Licensure.” If Michigan withdraws, their licenses will remain valid after March 28th. However, the Board will need to be ready to promptly issue guidance to the licensees who are impacted. There will be a discussion of some decisions the Board may need to make regarding the handling of licensees who hold licenses that can no longer be renewed through the Compact.
