- **Call to Order; Call the Roll; Acknowledge Guests:**

Dr. Matt Greenberg called the meeting to order at 12:01 PM

- **Approval of the Minutes of April 1, 2026, Board Meeting:**

D. Philibert moved to accept the minutes of the April 1, 2026 meeting. Dr. Tortolani seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

- **Board Issues:** Dr. Greenberg noted that the recent FSMB conference was valuable for all members who attended and invited attendees to share thoughts with the Board. G. Falk shared observations about three topics covered at the conference: artificial intelligence (AI) and the issues it raises for regulators of medical practice; emerging challenges with med spas, ketamine clinics, and GLP-1 clinics; and issues associated with the trend for physicians to be employed by entities that are not controlled by physicians, which creates issues with clinical decision making. She suggested that the Board form ad hoc committees to look at each of them. Dr. Tortolani, R.Ciappenelli, and Dr. King each shared comments about the meeting.

- **Administrative Updates (D. Herlihy):**
 - HSIN platform changes were noted. Members were thanked for their patience and extra time and effort to adapt to the changes and get their work done.
 - Dr. Fischer, UVM Dermatology, will present at the June meeting on issues associated with the use of lasers.
 - Members were reminded to submit expense forms as soon as possible. The state fiscal year ends on June 30, 2026, but past expenses need to be submitted well in advance.
- **Convene hearing to discuss any stipulations or disciplinary matters that are before the Board**
 - **Molly Smith PA-C, Hearing to Approve a Stipulation and Consent Order and Entry Agreement**

Justin Sheng, AAG, presented the Stipulation and Consent Order and Reentry Plan, which had been approved by the Licensing Committee, to the Board for approval. D. Philibert made a motion to accept the Stipulation and Agreement as presented. Dr. Eyler seconded the motion. The motion passed unanimously with the members of the Licensing Committee recusing.

- **Other Business:**
- **Discussion of bills of interest to the Board pending in the Vermont General Assembly**
 - **H.816, *An act relating to regulating the use of artificial intelligence in the provision of mental health services.***

A recent version of the bill being considered in the Senate was summarized. The draft includes a section that calls on the Board and the Office of Professional Regulation to prepare a report with recommendations for regulation of the use of AI by regulated professionals. Dr. Eyler commented that the bill does not address informed consent or acceptance of the use of AI by the patient. Dr. Tortolani raised the point that non-verbal cues play an important role in communication in general, and especially in discussing mental health issues. Dr. Eyler later questioned whether informed consent alone is adequate, asking whether there should also be a requirement for an alternative to care by AI.

- **VDH Policy Staff Discussion of S.142, *An act relating to a pathway to licensure for internationally trained physicians and medical graduates***

The Board was joined by Jessica Schifano, VDH Policy Advisor and Meg McCarthy, VDH Public Health Policy Advisor, to discuss the tasks assigned to the Board by S.142. VDH Policy staff has begun the process of researching the details of the programs established in other states to create alternate pathways to licensure for internationally trained physicians. The Policy staff will continue to support the Board in its work on this issue.

- **Ad Hoc Committees to Address Tasks from New Legislation**

Dr. Greenberg proposed forming two ad hoc committees. One to study AI issues as set forth in H.816 and the other to focus on the internationally-trained physician issue as presented by S. 142. D. Herlihy will send an email reminding members to reply stating if they are interested in joining one of the ad hoc groups.
