Approval of the Minutes of the June 7, 2023 and June 21, 2023 Board Meetings:

Dr. Bernstein moved to accept the minutes of the June 7, 2023, and June 21, 2023, meetings. Dr. Liebow seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

• Board Issues (Dr. Hildebrant):

Dr. Hildebrant acknowledged that there is a number of members scheduled to leave by the end of this calendar year. D. Herlihy shared that he has been working with the Governor's office and encouraging people to apply. D. Herlihy also shared that he anticipates some appointments to be coming through soon.

Dr. Hildebrant reminded the Board that this year, Dr. Bernstein will be leaving the Board. D. Herlihy offered a farewell and thanks to Dr. Bernstein for his services as a member with the Board. D. Herlihy reminded the Board that Dr. Bernstein began with

the Board in 2013 and shared appreciation for the time Dr. Bernstein has spent with the Board.

• Administrative Updates (David Herlihy):

D. Herlihy shared that J. Malago has returned to the office after leave and that T. Hayes is now out of the office and will return in the last week of July.

D. Herlihy reminded those in attendance that the State of Vermont celebrates Battle of Bennington Day on August 16th as a state holiday. This has caused the Mid-Month and South Committee meetings to be scheduled for August 23rd.

Presentation of Applications:

Applications for physician, physician assistant and limited temporary physician licensure were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

Dr. Hildebrant called for a motion for the issuance of physician licenses and physician assistant licenses. (See Appendix A)

S. Lorentz made a motion to accept all applicants for licensure as presented. Seconded by Dr. Tandoh. The motion passed; opposed: none; abstained: none; recused: none.

Dr. Hildebrant called for a motion for the issuance of limited temporary licenses to practice medicine. (See Appendix A)

Dr. Liebow made a motion to accept all applicants for licensure as presented. Seconded by Dr. Greenberg. The motion passed; opposed: none; abstained: none; recused: none.

Other Business:

• D. Herlihy presented the circumstances of Martin Carmody, DPM to the Board, explaining that the law prevents renewal of licenses for licensees who are unable to certify that they are in good standing with regard to taxes owed to the State of Vermont. Dr. Carmody asked the Board for a 30-day extension to get in good

standing with regard to Vermont taxes due to unreasonable hardship. D. Herlihy shared that 32 V.S.A. § 3113(g)(4) allows the Board to consider such requests. Dr. Greenberg made a motion to issue Dr. Carmody's renewal subject to the condition that it will be suspended with no further action by the Board needed if the Board does not receive the documentation of good standing with regard to Vermont taxes within 30 days and remain suspended until notice of good standing is received from the Vermont Department of Taxes. Seconded by PA-C Jones. The motion passed; opposed: none; abstained: none; recused: Dr. Liebow.

• Convene hearing to discuss any stipulations or disciplinary matters that are before the Board (12:49 PM):

In re: Robert Micley, MD – Stipulation and Consent Order – MPN 084-1020

Judge Belcher acknowledged AAG Campbell and Respondent's counsel, S. Hart, Esq. Judge Belcher inquired if the Respondent would attend; Hart, Esq. stated that the Respondent would not be present. Judge Belcher invited AAG Campbell to present the matter. AAG Campbell addressed the Board, summarizing the facts leading up to the Stipulation and Consent Order. Judge Belcher asked Attorney Hart if they would like to address the Board. Attorney Hart acknowledged the Board, explained that Dr. Micley had expressed his remorse for the conduct in a meeting with the North Committee, and offered thanks on behalf of Respondent. Dr. Liebow made a motion to approve the Stipulation and Consent Order. S. Lorentz seconded the motion.

- Other Business:
 - D. Herlihy reminded the Board of the annual retreat that typically is held in September or October. Dr. Hildebrant suggested that the retreat might be held at the in-person meeting scheduled for October of this year and asked for member input. Several members signaled support for having such a meeting. L. LeCours

noted that especially for members of the Licensing Committee it would be a very long day with the travel and asked for a virtual participation in the retreat to still be an option. G. Falk suggested that the Licensing Committee might me on a different day, possibly the Tuesday just before the Board meeting day. D. Herlihy shared the intention to make virtual participation an option for all Board meetings. Dr. Hildebrant acknowledged the uniform support for holding the retreat in October, and the potential for moving the Licensing Committee meeting that month. Dr. Hildebrant and D. Herlihy asked members for suggested topics of interest for the retreat. Several topics of interest were suggested. J. Malago will follow up with suggested topics and take a vote from Board members to determine which topics are of most interest.

 D. Herlihy provided an update regarding a revision of the Board's rules. D. Herlihy shared that he recently added a new provision to the changes he had previously shared with the Board. It is a new section regarding the makeup and quorum requirements for the Licensing Committee. It was added when there were concerns about having a quorum for the June meeting of the Licensing Committee. D. Herlihy shared the following:

The Licensing Committee of the Board is a standing committee that consists of at least three members, including at least one physician (MD) member and at least one public member of the Board. The Licensing Committee may conduct business with as few as two members participating but if only two members of the Licensing Committee are participating actions taken must be upon a unanimous vote and there must be a public member and a physician member present. If three or more members of the Licensing Committee are participating actions are taken on a majority of the members present and voting. Participation on the Licensing Committee is voluntary. Any sitting member of the Board of Medical Practice may volunteer for service at one or more meetings of the Licensing Committee.
