To Our Valued WIC Families,

The Abbott Similac recall has disrupted infant formula feeding for WIC families since February 2022. We know this has been a difficult time for families who use infant formula.

The Abbott company has full production of their Similac formula products and stores are now able to order and have in stock **Similac Advance, Similac Sensitive, Total Comfort and Isomil Soy**.

**Similac for Spit Up** has been discontinued. The Vermont WIC Program will add **Enfamil AR** to our formulary on a permanent basis due to Abbott no longer producing that type of product and will require medical documentation after February 2023.

The Abbott company will allow Vermont WIC to offer other companies' standard formulas that are substituted for **Similac Advance, Total Comfort, Sensitive, and Isomil Soy** through the end of **February 2023**.

**Beginning March 1, 2023**, WIC families will return to WIC Contract Formulas. As always, medical formulas can be provided to WIC participants with medical documentation if requested by health care provider.

Thank you for your understanding and patience with WIC as we worked through the impacts of the Abbott formula recall.
