

# **Community Prevention Grants**

#### **Division of Substance Use Programs**

March 2024

The Vermont Department of Health, Division of Substance Use Programs (DSU) is enhancing its prevention system to ensure equitable and sustainable substance use prevention statewide with the addition of general fund and cannabis excise tax revenue.

DSU seeks to increase state, regional and community capacity to deliver meaningful substance use prevention in all 12 public health districts by overlaying new and existing funding and initiatives to fill geographic and other identified gaps.

### **Funding supports prevention organizations**

Funding beginning in July of 2023 has supported activities across all substances and age groups with a focus on assessment and capacity-building activities, and work with populations including, but not limited to, the LGBTQ+ and BIPOC communities, people living in low-socioeconomic status (SES) households, refugees and English language learners, and people living in rural communities.
