Performance Category	Activities
RSO Certification	 RSO Certification granted by the Department of Health Press Release issued to local news & update to website
Governance	 Completion of Board (Governance) Attestation (includes term limits; board job descriptions; and use of board calendar tool, meeting agendas, and meeting minutes) Executive Director is certified in Non-Profit Management through a program approved by Department of Health (e.g., Common Good Vermont or equivalent training)
IRP & Notes	 Develop a procedure to enact supervisor review of IRP and notes in alignment with protocol outlined in the PRSS Manual Implement an identification process for participants remaining anonymous for note taking/IRP development


Performance Category	Activities
Recovery Coaching in the Emergency Department (RCED)	 Provide the baseline number of people who you met with in the ED who had an in-person follow up visit at the Center during the first 2 SOR grant quarters; this will be considered the baseline Increase the percentage of RCED in-person or phone contacts that have an in-person follow up visit within 30 days of the initial contact in quarter 3 and quarter 4 Develop a Quality Improvement Plan to increase the percentage of ED visits for substance use disorder where a recovery coach is called
Parents in Recovery	 Execute a formal written agreement (example: MOU) for referrals with at least one local <u>Parent Child Center</u> in your service area

Why Medicaid?



For Recovery Services Organizations



Medicaid presents the opportunity for a new sustainable funding stream and additional resources for those organizations that can increase their service delivery volume. The standards for RSO and PRSS Certification are building blocks towards Medicaid service delivery requirements and are also aligned to best practices.

Medicaid implementation can help **improve access to high-quality** services.




For the State




Waiver agreements, in combination with a state's Medicaid State Plan, generally reflect a state's priorities and goals. The RSS initiative is aligned to the stated SUD goals in Vermont's current Global Commitment to Health 1115 Medicaid Demonstration Waiver, including to increase access to care and improve quality of care.

Draft High-Level Timeline – Where We Are Going



*Activity involves significant coordination with entities outside of the Department of Health and timeframes represented here are estimates provided for educational purposes.

Draft Medicaid Rate Setting Example

- Earlier this summer, we were asked for an estimate of what a yearly budget might be for Recovery Support Services under Medicaid
- Today we are looking for feedback on the assumptions made for this initial estimate
- This is a starting point for this conversation; this is not an official or final rate but is shared to help provide transparency into the considerations included in rate-setting
- The Department of Health plans to work with the Department of Vermont Health Access Payment Reform team to develop a final rate for Recovery Support Services; your feedback today can help inform that future work

Draft Medicaid Rate Setting Example

Information we identified:

- 1. <u>Initial working draft rate</u> for recovery support services developed in coordination with Payment Reform based on national averages, identified as \$49.34/hour
- 2. Identified the <u>average number of Recovery Coaching participants</u> for FY24 and FY25
 - *At the time of this calculation, we only had 3 quarters of data to calculate, we took a one quarter average of the three quarters of data and applied it across all 4 quarters

Assumptions we made:

- 1. Each coaching session is 1 hour
- 2. Participants would average 6 Recovery Coaching sessions in total

Draft Medicaid Rate Setting Example – What did the numbers look like?

Category	Amount
Average Rate	\$49.34
# Served	3,107
Number of Sessions (# served multiplied by 6 average coaching sessions per participant)	18,642
Estimated Annual Budget Across all 12 RSOs	\$919,796

Celebrating Accomplishments & Reflecting on Learnings from Certification Process

Key Accomplishments This Year!

As a full group, Recovery Centers have accomplished key milestones this year as part of the RSS initiative:

- Foundational Visits: Throughout the spring, the Department of Health met with each Recovery Center to
 discuss, among other topics, areas of opportunity for Recovery Center governance and board
 development and ways to enhance current referral systems.
- Time Study: Recovery Centers processed the results of the 2024 Time Study and used them to inform
 considerations related to current service delivery and staffing models.
- Service Delivery Enhancements: In this year's RCD Touchpoints, we have worked together on implementing a full package of RSS service delivery measures, including the standardized IRP and Medical Necessity determination.
 - Finalizing these materials is a big step toward meeting the documentation and medical necessity requirements of the Medicaid Service Delivery Model.
- Certification Programs: Recovery Centers have been applying for RSO Certification, and Recovery Center employees have begun to receive PRSS Certification.
 - As of the end of September, **4 Centers** have applied for **RSO Certification**, and **14 individuals** have received **PRSS Certification**!






Claiming a Sense of Agency: Being Proactive
