
RSS Initiative Status Update

RSS Initiative Status Update

	Component	Objective	Status
	Peer Recovery Support Specialist (PRSS) Certification	To develop and operationalize a process for PRSS certification via the Office of Professional Regulation (OPR) based on the International Certification & Reciprocity Consortium (IC&RC) Peer Recovery credential.	VDH-DSU is working with OPR and DMH to address public comments on the PRSS Certification Rule. Proposed rule filing with LCAR is anticipated for April. There is an agreement in place with Prevention Works to serve as the credentialing body overseeing IC&RC credentialing of applicants.
⊞	Recovery Services Organization (RSO) Certification	To develop and operationalize a process for certification of RSOs, building upon existing work to accredit organizations who maintain a high standard of service.	The RSO Certification Rule was adopted with an effective date of July 1, 2025. VDH-DSU is currently developing the application and site visit process.
	Foundation Building Exercises	To learn more about Recovery Center operations and areas of support needed for upcoming certifications and for Medicaid.	In-person Foundational Visits with each Recovery Center will continue through April. Topics of discussion include Governance/Board, Time Study Results, Referral Networks, and RSO/PRSS Certification. Board development coaching calls have been scheduled.
5	Medicaid Benefit Design & Rollout Vermont Department of Hea	To design and implement a Medicaid benefit system for RSS and to make any necessary adjustments to support Medicaid reimbursement of RSS.	VDH-DSU is currently developing key components of the Medicaid service delivery design, including a template for Individualized Recovery Plans and criteria for medical necessity.

Key Takeaways

- Some Recovery Centers use the same template across different settings and others use different templates for different settings
- Some Recovery Centers do not use a recovery plan template in the Emergency Department
- A variety of tools are currently in use, including the My Wellness Plan and Recovery Management Plan within RDP
- Sample templates include sections on recovery management planning, life domains assessment, stages of change, action planning, setting SMART goals, and prompts for participants to reflect on their daily planning and support systems
