# **Measure Description**

Patient Burn (ASC-1)

- this measure shows the number of patients admitted to an ASC who experience a burn before their discharge. Lower rates are better.

### Patient Fall (ASC-2)

- This measure shows the number of admissions (patients) who experience a fall within the ASC. Lower rates are better.

## Wrong site, wrong side, wrong patient, wrong procedure, wrong implant (ASC-3)

- This measure shows the number of admissions (patients) who experience a wrong site, side, patient, procedure, or implant. Lower rates are better.

# Hospital transfer/admission (ASC-4)

- This measure shows the percentage of ASC admissions (patients) who are transferred or admitted to a hospital upon discharge from the ASC. Lower rates are better.

# Percentage of patients receiving appropriate recommendation for follow-up screening colonoscopy (ASC-9)

- This measure shows the percentage of patients aged 50 to 75 whose colonoscopy didn't require removal of a polyp or a biopsy and who received a recommendation for having their next follow-up colonoscopy in 10 years. Higher percentages are better.

# Percentage of patients with history of polyps receiving follow-up colonoscopy in the appropriate timeframe (ASC-10)

• This measure shows the percentage of patients 18 and older receiving a surveillance colonoscopy, with a history of a prior colonic polyp(s) in previous colonoscopy findings, who had a follow-up interval of 3 or more years since their last colonoscopy. Higher percentages are better.

#### Percentage of patients who had cataract surgery and had improvement in visual function within 90 days following the surgery (ASC-11)

- This measure shows the percentage of patients 18 and older who had cataract surgery and had improvement in visual function achieved within 90 days following the cataract surgery.

#### Rate of unplanned hospital visits after an outpatient colonoscopy (ASC-12)

- For each ASC, the measure estimates how often patients over 65 have an unplanned visit to the hospital, for any reason, within 7 days of receiving a colonoscopy procedure. Lower rates are better.

Percentage of patients who received anesthesia who had a normal body temperature within 15 minutes of arriving in the postanesthesia care unit (ASC-13)

- This measure shows the percentage of surgical patients under surgical anesthesia for 60 minutes or more who had a body temperature of at least 96.8 degrees within 15 minutes of arrival at the Post Anesthesia Care Unit (PACU). Higher rates are better.

#### Percentage of cataract surgeries that had an unplanned additional eye surgery (anterior vitrectomy) (ASC-14)

- This measure shows the percentage of cataract surgeries that had an unplanned anterior vitrectomy. Lower rates are better.
