

## Notisi ya Ushauri: Maagizo ya Bidhaa Zinazodhibitiwa

### Mahitaji ya Kufuatilia:

Sheria ya Vermont (18 V.S.A. Sura ya 84A) inahitaji Idara ya Afya ya Vermont kuanzisha Mfumo wa Kufuatilia Dawa wa Vermont (VPMS). VPMS ni hifadhi data ya kielektroniki na mfumo wa kuripoti kwa kufuatilia bidhaa zinazodhibitiwa za Ratiba ya II, III, na IV. Bidhaa zinazodhibitiwa ni dawa zilizo na uwezo kiasi wa kutumiwa vibaya au kutegemewa. Dawa hizi zinadhhibitiwa na Sheria ya Shirikisha Bidhaa Zinazodhibitiwa (CSA) – sheria hii husaidia Serikali ya Marekani kupambana na matumizi mabaya ya dawa hizi. Mifano ya bidhaa zinadhhibitiwa inajumuisha oksikodoni, methadoni, haidrokodoni, buprenofini, clonazepam na diazepam.

VPMS ni kama kifaa cha kimatibabu kwa watoa huduma za afya kukuza matumizi yanayofaa ya bidhaa zinazozuiwa kwa madhumuni halali ya kimatibabu, huku kikizuia matumizi mabaya na kubadilisha matumizi ya bidhaa zilizozuiwa. Data hutumiwa kusaidia juhudi za majimbo katika elimu, utafiti, utekelezaji na uzuiaji wa matumizi mabaya

Data hii ni ya siri, isipokuwa inavyosemwa katika sheria, na haitumiki kwa sheria ya rekodi za umma.

## Advisory Notice: Prescriptions for Controlled Substances

### Monitoring Requirements:

Vermont law (18 V.S.A. Chapter 84A) requires the Vermont Department of Health to establish the Vermont Prescription Monitoring System (VPMS). The VPMS is an electronic database and reporting system for monitoring Schedules II, III, and IV controlled substances. Controlled substances are drugs that have some potential for abuse or dependence. These drugs are regulated by the federal Controlled Substances Act (CSA) – this law helps the US Government fight against the abuse of these drugs. Examples of controlled substances include oxycodone, methadone, hydrocodone, buprenorphine, clonazepam and diazepam.

The VPMS serves as clinical tool for health care providers to promote the appropriate use of controlled substances for legitimate medical purposes, while deterring the misuse, abuse, and diversion of controlled substances. The data is used to support states' efforts in education, research, enforcement and abuse prevention

This data is confidential, except as provided in the law, and is not subject to the public records law.

### Data Collected:

- Patient Name, Address, and Date of Birth
- Drug Dispensed, Date, Quantity and Dosage, Number of Days' Supply, Number of refills
- Patient's Health Care Provider
- Pharmacy Name (where prescription is filled)
