  - Extension of Effective Date of Act 91 regarding emergency provisions for the COVID-19 state of emergency. Some of the emergency authorities created in the law are in force only so long as there is a declared state of emergency. The General Assembly has been asked to amend the law to extend the effective date to a date sometime in 2021. Discussion and request for Board position on how long those provisions should extend (primary issues of concern are the different forms of emergency licenses).
  - Posted actions and profiles of deceased licensees a question has arisen as to whether actions taken against licensees who subsequently die during the ten-year period when actions are posted on the Board website should continue to be posted after staff learns of the death.
  - CME requirements and renewal process for MD licenses expiring on November 30, 2020 - many state licensing boards have suspended or modified CME requirements during the COVID-19 state of emergency. Some states have extended licenses or delayed the expiration date/renewal process for licenses. Discussion and request for Board position as to whether there should be such changes for the Vermont MD renewal.
