## Gerber the Vermont WIC Nutrition Program Contract Infant Formula Effective 9-29-2019

August 2019

Dear Colleague:

Effective September 29, 2019, there will be a change to the **standard** infant formulas offered by the Vermont WIC Nutrition Program due to a change in the state's infant formula rebate contract. Engaging in an infant formula rebate contract is a federal requirement from USDA.

- Gerber Good Start Gentle and Gerber Good Start Soy will be the primary WIC milk- and soy-based formulas replacing Similac Advance and Similac Isomil.
- **Gerber Good Start Soothe** will also be available to families *without* a prescription replacing Similac Total Comfort, Similac Sensitive for Fuss & Gas, and Similac for Spit Up.

The Vermont WIC Program serves approximately 11,200 participants each month, including 1,100 fully formula fed infants. We are asking all Vermont practitioners to **use Gerber formulas for WIC infants fed standard formula** so infants will not have to switch formulas when they are certified for WIC services. All other <u>medical</u> formulas will continue to be available for infants with appropriately documented diagnosed medical conditions.

The **medical documentation form** used when requesting medical formula or medical food has also been updated. Highlights include allowing infant medical formula prescriptions to **extend up to age 1** and only requiring an updated form on an annual basis for children over age 1. WIC will continue to promote **breastfeeding as the preferred infant feeding method**. WIC offers a wide range of breastfeeding services, including individualized lactation support, peer counselors, prenatal breastfeeding classes, and help accessing pumps.

WIC is providing the following formula transition instructions to families with infants on the affected formulas:

## Transitioning Your Baby to a New Formula

WIC is here to help you and your baby through this transition. Most babies will switch to their new formula without any problems. Some parents may notice minor changes in feeding patterns when switching their babies to a new formula.

A good way to make the change is to slowly mix the old formula with the new formula over a period of about a week.

Instructions:

- Prepare some of the new formula and some of the old formula separately, then mix the two prepared formulas together as described in the chart below.
- Use less of the old formula and more of the new formula in each bottle over the course of the transition.
- Look for the amount of formula your baby drinks at a feeding in the left-hand column.
- Then, using columns to the right, mix the amount of current formula with the amount of the new Gerber formula.
- Continue to adjust the current formula down and the Gerber formula up over the course of the week.

Find the Amount of Formula Your Baby Drinks at Each Feeding:	Days 1 and 2	Days 3 and 4	Days 5 and 6	Day 7
4 oz bottle	3 oz current formula + 1 oz Gerber	2 oz current formula + 2 oz Gerber	1 oz current formula + 3 oz Gerber	4 oz Gerber
6 oz bottle	4 oz current formula + 2 oz Gerber	3 oz current formula + 3 oz Gerber	2 oz current formula + 4 oz Gerber	6 oz Gerber
8 oz bottle	6 oz current formula + 2 oz Gerber	4 oz current formula + 4 oz Gerber	2 oz current formula + 6 oz Gerber	8 oz Gerber
