The Child Care Wellness Consultant Program is in transition. The program funded by Vermont's Early Learning Challenge Grant and managed by the Vermont Department of Health since 2014 will be ending as of December 31, 2017. Medication Administration Trainings (MAT), a positive and lasting product from this effort, will be continued and transitioned to Vermont's Early Childhood Comprehensive Professional Development System – Northern Lights at CCV (Community College of Vermont) – effective January 2018. We continue to plan for how to best offer and sustain ongoing phone and on-site heath consultation and other technical assistance and support for child care and early learning programs. For the foreseeable future, Maternal and Child Health nurses in the Vermont Department of Health District Offices will be available to child care and early learning programs and professionals for questions regarding health and safety issues and connections to community health resources.
