PROGRAM UPDATES

Decrease in Vaccines Administered due to COVID-19

<u>Data</u> recently provided through Vermont's Immunization Registry compares the number of vaccines administered from February-May 2019 and 2020. Vermont's experience has been consistent with the U.S – where there was a dramatic decrease in vaccines administered in April. Recent Vermont data show a partial rebound in May. It is clear that COVID-19 containment efforts greatly impacted vaccine administration in primary care practices. Efforts to catch-up kids on vaccines will be important in order to prevent outbreaks of measles, whooping cough and other vaccine preventable diseases.

Vaccine Inventory Adjustments

The CDC requires that we not return any vaccines prior to their expiration date, not even flu. All viable vaccine should be kept in the fridge until expiration. Once expired, you may enter an adjustment in VIMS and package the vaccines for return. For the *adjustment type* choose: **Return** and the *adjustment reason* choose: **Expired**. A return label will be emailed to you so the vaccines can be shipped back to McKesson. If you do not receive a return shipping label within 48 hours of submitting your adjustment, check your junk mail folder and if not there, please contact the Immunization Program Specialist elan.curran@vermont.gov

School Immunization Rates

The Immunization Program webpage for <u>Vermont school vaccination coverage data</u> has been updated for school year 2019-20.

The percentage of Vermont K -12 students meeting all vaccine requirements remains high, increasing this past school year to 95.1%. Kindergartners also reached an all-time high, up-to-date rate of 92.2%. Rates of exemption and provisional admittance declined in both groups.

School entry requirements will remain in effect this fall. See more detail and congratulations in the memo, <u>Compliance with Vermont's Immunization Law and</u> <u>Regulations</u> from Commissioner of Health, Mark Levine, M.D. and Secretary of Education Daniel M. French, Ed.D.
