


## **Overview**

This Psychiatrist report is part of the Vermont Department of Health's health care provider data program, which is used to monitor and measure the supply of health care providers in Vermont over time. Data for this report were obtained from the 2016 censuses of osteopathic (DO) and allopathic (MD) physicians, selecting all those who reported practicing in Vermont with a main specialty of psychiatry.

Psychiatrists are doctors that focus on the diagnosis, treatment, and prevention of mental, emotional, and behavioral disorders and are an essential part of the mental health care workforce.

\*Numbers differ from those in the 2016 physician report because this report includes data on 14 psychiatrists working as locum tenens (practitioners filling positions on a temporary basis, typically for a year or less).



## Workforce

- 189 physicians indicated psychiatry as their main specialty out of the 2182 physicians completing the census in 2016.
- Two additional physicians reported psychiatry as a secondary specialty they are not included in the total count of psychiatrists but their 0.5 FTEs working in psychiatry are included.
- Out of the 189, 170 indicated that they were active and providing direct patient care in Vermont, one was working through telemedicine but had a specific work location in Vermont, four were working through telemedicine without a specifically designated Vermont location, and 14 were working as locum tenens (temporary placement).
- The remainder of this report is based on all 189 psychiatrists. Numbers will be slightly increased from the 2016 physician report where locum tenens physicians were excluded from most tables.

# **Demographics**


#### Gender

- 45.0% were female.
- 55.0% were male.

## Age

- 21.2% of psychiatrists were younger than 45.
- 29.1% of psychiatrists were 65 or older.

# **Education and Training**

- Almost half (47.9%) completed medical school in the Northeast.
- Two out of three (67.6%) psychiatrists completed their residency in the Northeast.

## Access to care (office settings only)

- 89.2% accepted new patients.
- 89.9% participated in Medicaid.
- 79.7% accepted new Medicaid patients.
- 92.6% participated in Medicare.
- 83.0% accepted new Medicare patients.

# **Number of practice sites**

- 18.8% (36) of psychiatrists practiced at 2 or more locations.
- 5.2% (10) of psychiatrists practiced at 3 or more locations.

# **Practice setting**

• For psychiatrists' main practice location, the most common setting was inpatient departments in hospital followed closely by solo practices.


# **Full Time Equivalents**

- 20.3% worked 40 hours or more per week at their main site.
- 121.0 total FTEs were provided by 189 psychiatrists.
- 56.6 FTEs, or 46.8% of total FTEs, were age 60 and older (88 individuals).


# Psychiatrist FTEs per 100,000 Population by Blueprint Health Care Areas



# **Blueprint Health Care Areas** (see Appendix for details)

- Brattleboro Health Care Area had the highest FTE per 100,000 population at 73.9, close to three times greater than the next highest area, Barre.
- Newport Health Care Area had less than six FTEs per 100,000 population.

# **Mental Health Catchment Areas** (see Appendix for details)

- Northeast Kingdom Health Services (NKHS) had the lowest ratio of 5.8 FTEs per 100,000 population.
- Highest ratio was 39.8 FTEs per 100,000 population in Health Care and Rehabilitation Services of Southeastern Vermont (HCRS) area.



# **Current Experience and Future Plans**

Median amount of time licensed in Vermont: 14 years.

#### In the next 12 months

- 5.9% planned to retire.
- 12.9% planned to reduce their hours.

## **Observations**

- Grand Isle and Essex Counties had no reported FTEs from psychiatrists. FTEs vary widely by geographical areas.
- 12.9% of active VT psychiatrists planned to reduce their hours.
- 89.2% of active VT psychiatrists reported that they are accepting new patients.

# **Appendix**

#### **Active Psychiatrist**

A psychiatrist who reported working in Vermont as such (regardless of how many hours) is considered active.

#### Census

The census was taken during the biennial physician license renewal which ended on November 30, 2016. This report is derived from a subset of those physicians who indicated a specialty of psychiatry in that census. Census questions available upon request.

## **Full Time Equivalent (FTE)**

Full time is defined as 40 or more working hours in Vermont per week, 48 weeks or more per year. Reporting more than 40 hours per week is defined as <u>one</u> FTE regardless of the number of hours over 40 per week worked.

#### **Health Care Areas**

The Health Care Areas in this report are those used by the Vermont Blueprint for Health, an initiative working to transform the way primary care and comprehensive health services are delivered and paid for. It disseminates information on healthcare expenditures, utilization, and care quality measures within these regions (see <a href="http://blueprintforhealth.vermont.gov/">http://blueprintforhealth.vermont.gov/</a>). Data are available for other regional definitions from the Division of Health Surveillance. See the contact information at the end of this report.

#### **Locum Tenens**

Locum tenens practitioners fill positions on a temporary basis when practitioners are on sabbatical, vacation, or absent for an extended period.

#### Main Practice, Site, Setting, and Specialty

The main practice site, setting, or specialty of an individual refer to the practice site, setting, or specialty with the greatest number of reported annual hours.

#### Maps

For county map, colors define quartiles. The lowest 25% of FTE equivalents to population ratio is displayed in the lightest color, the middle 50% in medium, and highest 25% in the darkest color.

#### **Mental Health Catchment Areas**

There are 10 designated agencies across the state of Vermont responsible for helping their local populations access mental health services among other things.

#### **Weekly Hours**

Average weekly hours is based on hours and weeks reported, adjusted to a full-time 48-week working year (hours \* (weeks/48)). Thus, the average weekly hours for an individual working 40 hours a week for half the year (24 weeks) is 20.
