


2016 Psychotherapists

Overview

This Psychotherapist census is part of the Vermont Department of Health's health care provider data program, which is used to monitor and measure the supply of health care providers in Vermont over time. A roster of Vermont non-licensed, non-certified psychotherapists is updated every two years. Data for this report were obtained during the November 2016 roster period and represent a snapshot of the profession at that time.

Psychotherapists provide treatment, diagnosis, evaluation, and/or counseling services to alleviate mental disorders. They are part of the allied mental health professional workforce in Vermont. If someone is providing psychotherapy services but is not currently licensed as another allied mental health professional, they are required to be entered on the roster. This includes psychologists, clinical social workers, mental health counselors, and marriage and family therapists who have completed the education requirements for their license and are currently working on their supervised practice hours.

Workforce

DEPARTMENT

- 860 psychotherapists renewed their roster entry during the census period and 856 completed the workforce survey for a response rate of 99.5%.
- Out of the 856 respondents, 747 (87.3%) indicated that they were active and providing direct patient care in Vermont as psychotherapists.
- Of the 109 respondents who reported a non-active status, 59 (54.1%) indicated they planned to start providing direct patient care in Vermont within the next 12 months.
- The remainder of this report is based on the 747 psychotherapists who reported being active and providing direct patient care in Vermont as psychotherapists. One active respondent did not provide any site or hour information, so they were not included in totals of practice characteristics or FTEs.

Demographics


Gender

- 76.3% were female.
- 23.3% were male.

Age

- 60.8% of psychotherapists were younger than 45
- 6.8% of psychotherapists were 65 or older

Education and Training

DEPARTMENT OF HEAL

- 86.7% (645) had a master's degree.
- 4.0% (30) had a doctoral degree (PhD/PsyD/EdD).
- 81.9% completed their education in the Northeast.

Additional licenses

- Many rostered psychotherapists were licensed in another mental health profession.
 - 26 were mental health counselors.
 - 101 were alcohol and drug abuse professionals.
 - 7 were psychologists.
 - 19 were clinical social workers.
 - o 1 was a marriage and family therapist.
 - 2 were registered nurses.

Access to care

DEPARTMENT

- 91.4% accepted new clients.
- Data was not collected on Medicaid and Medicare acceptance as non-licensed, non-certified psychotherapists are typically not eligible to charge as providers to those programs.

Number of practice sites

- 6.8% (51) of psychotherapists practiced at 2 or more locations.
- 0.3% (2) of psychotherapists practiced at 3 or more locations.

Practice setting

• For psychotherapists' main practice location, the most common setting was community mental health centers and designated agencies, followed by independent solo practices.

- 35.8% worked 40 hours or more per week at their main site.
- 530.5 total FTEs were provided by 746 psychotherapists.



Psychotherapist FTEs per 100,000 population by Blueprint Health Care Areas




Blueprint Health Care Areas (see Appendix for details)

• Barre (119.0), Burlington (105.7), and Middlebury (109.8) Health Care Areas had the highest ratio of psychotherapist FTEs to population.

• Springfield, St. Johnsbury, Newport and Windsor Health Care Areas had less than 55 FTEs per 100,000 population.

Mental Health Catchment Areas (see Appendix for details)

- Northeast Kingdom Health Services (NKHS) had the lowest ratio of 50.4 FTEs per 100,000 population.
- Highest ratio was 120.8 in Washington County Mental Health Services (WCMH) area.



Current Experience and Future Plans

• Median amount of time rostered in Vermont: 3 years.

In the next 12 months

- 74.9% planned to continue working as they had been.
- 18.2% planned to increase their hours.
- 2.4% planned to reduce their hours.

Future professional tracks

- 40.6% planned to be licensed as a mental health counselor.
- 17.0% planned to be licensed as a social worker.
- 11.6% planned to be licensed as a psychologist.
- 10.6% planned to be licensed as an alcohol and drug counselor.
- 2.3% planned to be licensed as a marriage and family therapist.
- 19.9% were not planning on acquiring any of the licenses above.

Appendix

Active Psychotherapist

A psychotherapist who reported working in Vermont as such (regardless of how many hours) is considered active.

Census

The census was taken during the biennial psychotherapist roster process which ended on November 30, 2016. The data include all rostered psychotherapists except for new psychotherapists enrolled less than three months before the renewal date (September 2016 – November 2016), as their enrollment was valid until the next renewal date of November 30, 2016. Census questions available upon request.

Full Time Equivalent (FTE)

Full time is defined as 40 or more working hours in Vermont per week, 48 weeks or more per year. Reporting more than 40 hours per week is defined as <u>one</u> FTE regardless of the number of hours over 40 per week worked.

Health Care Areas

The Health Care Areas in this report are those used by the Vermont Blueprint for Health, an initiative working to transform the way primary care and comprehensive health services are delivered and paid for. It disseminates information on healthcare expenditures, utilization, and care quality measures within these regions (see http://blueprintforhealth.vermont.gov/). Data are available for other regional definitions from the Division of Health Surveillance. See the contact information at the end of this report.

Main Practice, Site, Setting, and Specialty

The main practice site, setting, or specialty of an individual refer to the practice site, setting, or specialty with the greatest number of reported annual hours.

Maps

For county map, colors define quartiles. The lowest 25% of FTE equivalents to population ratio is displayed in the lightest color, the middle 50% in medium, and highest 25% in the darkest color.

Mental Health Catchment Areas

There are 10 designated agencies across the state of Vermont responsible for helping their local populations access mental health services among other things.

Weekly Hours

Average weekly hours is based on hours and weeks reported, adjusted to a full-time 48-week working year (hours * (weeks/48)). Thus, the average weekly hours for an individual working 40 hours a week for half the year (24 weeks) is 20.
